Great Parks worked with the Whitewater Trails developer to provide a link to the shared-use trail system in Miami Whitewater Forest. This link, which starts near the entrance of the Whitewater Trails neighborhood, extends east for approximately 1/3 mile before connecting with the trail. A parking lot located south of the pond on the north side of Baughman also provides an option for parking closer to the trail. To our knowledge, these connections are open for use. We are currently in the process of identifying possible locations and configurations for the new canoe/kayak launches. Funding for this project will come from a combination of sources. Great Parks will be responsible for funding project components located on park properties. Typically, our projects are supported by levy funds leveraged with supplementary support from federal, state and local grant funding sources. We're working to develop partnerships with local communities and jurisdictions to help secure funding and construction management for project components located outside park boundaries.

		Our project team (comprised of Great Parks representatives and our project consultant team led by Kimley-Horn) is looking at a broad variety of options for the shared-use path, which could include using old or retired railways, if they are available. More will be known on that front as we get further into the study. As part of the process for identifying potential routes for the shared-use trail, the project team is identifying and examining a variety of conditions such as traffic volumes along nearby roads and intersections; opportunities to connect to other nearby trails, local communities, points of interest, etc.; potential impacts along proposed routes; and potential concerns, which includes possible flooding and how related impacts would be managed. Details related to these and other topics will be explored in more detail as planning progresses.

What about a campground expansion I heard that might be coming to Miami Whitewater Forest.	Thank you for your question. Great Parks looked into a new campground at Miami Whitewater Forest during the process of developing a master plan for the park in 2019-2020. However, an ideal location was not able to be determined at that time, and the idea needs to be investigated in more detail in the future.
SOCIAL MEDIA	What about the Rumpke Landfill on Bond Road and stormwater runoff from that site?	Thank you for your support and your question regarding the West Region Blueway & Trail System. While the Bond Road Landfill property is not adjacent to the area that will be included in the scope of this project, Great Parks intends to identify opportunities for habitat restoration in areas that are part of the site development for the shared-use trail or river access sites included in the project. Great Parks' broader natural area management plan goals are to provide a diverse representation of native plants, animals, and habitats. Higher priority is given to the more rare and endangered resources. The majority of effort is spent on protecting water quality, monitoring resources like plants and wildlife, stewarding mature and urban forests, and removing invasive plant species.
